- 1. Burial Ground Inspection Councillors inspected the Burial Ground
- 2. To receive apologies for absence None
- 3. To receive members Declarations of Interest No declarations were made
- **4. To consider Applications for Dispensations** No applications for dispensation were submitted.
- 5. Councillors noted the Minutes of the Burial Board meeting held on Tuesday 19<sup>th</sup> September 2017 were approved at the Parish Council meeting on Monday 9<sup>th</sup> October 2017
- 6. Public presentation There was no public representation
- 7. The meeting resumed
- 8. To consider actions in relation to the Burial Ground inspection

The Burial Board confirmed that, further to inspection of all aspects of the burial ground, the following:

- **8.1 Benches** Councillors agreed that all the benches are in need of cleaning/wood treatment which will be carried out during the summer. Cllr. Lewis volunteered to prune one of the small trees in the New Burial Ground in order to reinstate a memorial bench onto paving stones which are positioned under the canopy of the tree.
- 8.2 Trees, bushes, hedges (including large tree in OBG) To be reviewed in September 2018
- **8.3 Headstones** Remedial works to Grave 246 (NBG) and Grave 93 (OBG) have been completed and can be removed from the list.
- **8.4 Memorials with some movement but concurred ground anchor in place** Three additional headstones in the New Burial Ground are to be added to the 'watch' list.
- 9. To consider and review the Transfer of Deed re: Exclusive Right of Burial:
  - 9.1 No amendments made
  - **9.2** The Clerk confirmed that since its introduction last year, owners of new graves have mostly returned the Transfer of Deed which will be kept on file.
