Minutes of the Nether Alderley Burial Board Meeting held on Monday 5th September 2022 at 5.00 p.m. Nether Alderley Parish Hall

1. Inspection of the Burial Ground – An inspection of the Burial Ground was carried out by the Burial Board and the Clerk on Monday 5th September 2022.

- 2. To receive apologies for absence None
- 3. To note the Minutes of the Burial Board meeting held on Tuesday 12th April 2022 which were approved by Nether Alderley Parish Council on 10th May 2022
- **4.** Public Presentation There were no members of the public present
- 5. To resume the meeting
- 6. To exclude the public and press in the public interest for consideration of the following items:
 - a. Personal issues

- 7. To consider and approve actions to take following the Burial Ground inspection:
 - **7.1 Gate into the field (off the car park)** Councillors noted the long grass at the entrance to the field but concurred it will die back over the Autumn/Winter.
 - **7.2** Paths Groundsman to cut back brambles by the side entrance of the Parish Hall and treat in Spring 2023.
 - 7.3 Kissing Gates (x2) Groundsman to strim the long grass within the area of the turning.
 - **7.4** Benches Two benches remain untreated:
 - William Morris Bench (outside the Parish Hall)
 - A bench commemorating Marks/Hobson family) in the new burial ground

In addition to the above, the bench at the rear of the Parish Hall requires some remedial work.

Cllr. Farrell was asked to contact a local handyman to treat the benches and repair the bench.

- 7.5 Steps and Railings
 - The railings leading down to the new burial ground require a wood treatment which will be included as part of the works carried in 6.4.
 - The notices will be replaced on the handrails leading down to the new burial ground.
 - The Groundsman will be asked to clear the steps leading down to the new burial of moss/leaves.
- 7.6 Mausoleum: Steps to the crypt
 - **7.6.1** The steps leading down to the crypt are in need of some attention as leaves have gathered which obstruct the door and foliage/moss need to be removed from the steps which will be carried out by the Groundsman.
 - **7.6.2 Front door to the crypt** A local handyman had placed a piece of glass across the small crack above the right-hand side of the door where some of the grouting is missing. The Burial Board noted there has been no movement as the glass is still in tact.
- 7.7 Gate in the New Burial Ground No action required.
- 7.8 Bins (x4) No action required.
- **7.9** Water Source No action required.

- **7.10** Trees, bushes, hedges (incl. large tree in OBG) The Burial Board noted the tree which was planted in memory of Noni Watkins is too close to the tree to the left of it. Councillors recommended the tree should be repositioned between the 2 benches.
- 7.11 Other (Watering cans x 2) No action required
- **7.12 Compost Bin** The Burial Board noted the compost bin is full and includes woody and other material which is not compostable. A sign will be posted asking users to take home anything which is not compostable.
- **7.13 Memorial Headstone: OBG 36** Permission had previously been granted to re-instate the memorial but nothing has been done as yet due to the family self-isolating during COVID-19.

Memorial Headstone: OBG 98 – The Burial Board agreed to remove the memorial headstone from the 'watch list' as the front of the memorial headstone which is coming away, is aesthetic and not dangerous.

Memorial Headstone: NBG 228 – The memorial headstone is not anchored and has become detached from the plinth. The Clerk was asked to contact a local stonemason to establish if there is a product available which will re-bond the memorial to the plinth.

- 16.1 A recent enquiry to establish if an individual dwelling was included on the map of the Ecclesiastical Parish of St. Mary's, Alderley The Clerk reported that she had consulted with the person who maintains the roll book of St. Mary's, Alderley who suggested the dwelling looked as though it was in the Parish of St. Philip's and St. James. Confirmation was sought from the Vicar of St. Philips and St. James who also suggested the dwelling was probably in the Parish of St. Philips and St. James. Councillors referred to the Ecclesiastical map which was difficult to decipher and asked the Clerk to make further enquiries before confirming this information to the resident concerned.
