- Burial Ground Inspection Cllr. Lewis and the Clerk had carried out the inspection on Wednesday 2nd September 2020 due to social distancing re: COVID-19
- 2. To receive apologies for absence Cllr. Y.Bentley
- 3. To receive Declarations of Interests
 - 3.1 To Declare Disclosable pecuniary interests No declarations were made.
 - **3.2 To Declare interests conflicting with Nolan principles/non- pecuniary interests -** No declaration were made.

 - 6.1 Gate into the field (off the car park) The grass is long at the entrance to the field and requires strimming as it may obstruct vehicle access in the future. (Inform the Groundsman)
 - **6.2** Paths The path outside the Parish Hall requires a weed treatment before Winter and there are areas where the pointing is missing between the paving stones.
 - 6.3 Benches The Burial Board thanked Cllr. Lewis for treating all of the benches during the Summer.
 - **6.4** Steps and Railings The railings leading down to the new burial ground require a wood treatment and the notices replaced.
 - 6.5 Mausoleum: Steps to the crypt The steps leading down to the crypt are covered in leaves and moss which need to be removed. (Inform the Groundsman)
 - **6.6 Mausoleum: Door to the crypt** A decorative moulding on the left-hand door has become detached and needs re-fixing which the Clerk will organise.
 - 6.7 Trees, bushes, hedges (incl. large tree in OBG) It was noted the hedge is due to be cut.
 - **6.8 Compost Bin** It was noted some hedge clippings have been put into the compost bin and should be removed as they do not rot down.
 - **6.9** Memorial Headstone: OBG 68 The Clerk confirmed the headstone has been re-instated by the family and inspected by the Clerk. (Remove from the report)
 - **6.10 Memorial Headstone: OBG 36** Permission had previously been granted to re-instate the memorial but nothing has been done as yet due to the family self-isolating re: COVID-19.
 - **6.11 Memorial Headstone: OBG 165** The headstone has been laid flat on the existing kerb stones and made safe. The Clerk confirmed she has been unable to contact the family. (Remove from the report)
