8. Current Matters

To consider and agree actions relating to ongoing matters as follows:

- 8.1 Cheshire East update by Ward Councillor No update available as Cllr. Marc Asquith was not present.
- 8.2 Parish Hall renovation update:
 - **8.2.1 General Update** A meeting with Mark Pearce (KPS) had taken place earlier in the day. The definitive plans, planning statement etc. should be available by the end of January 2020 and it was envisaged that a detailed planning application would be submitted to Faculty and Cheshire East Planning Department by Easter 2020. A meeting with the Quantity Surveyor will be scheduled asap.

8.2.2 Revised Fee Proposal for Architectural Services (RIBA work: Stage 2-6) – Councillors were asked to consider a revised fee proposal from KPS confirming works which have been completed and those requiring formal instruction to proceed.

RESOLVED: The Parish Council resolved to approve the revised fee schedule:

RIBA Work Stage 3 Development Design – Phase 2 (£2,415 plus VAT) RIBA Work Stage 4 Technical Design – Phase 3 and 4 (£4,830 plus VAT)

It was noted that these costs are exclusive of external fees and charges including the Planning Application and Faculty Application.

- **8.3 Proposed free newsletter and distribution –** Representatives from the Parish Council and St. Mary's Church met on Friday 8th November 2019 to discuss producing a free newsletter to the local community. The following was agreed:
 - A simple A4 double sided community newsletter would be produced every other month.
 - The newsletter would be free and hand delivered to the 'Friends of Nether Alderley' by volunteers. (Additional volunteers still required)
 - Local residents would be encouraged to submit articles via a dedicated email address.
 - Initial costs would be low as Cllr. Sue Joseph kindly volunteered to do the photocopying and the paper would be supplied by St. Mary's.
 - The newsletter would not include advertising from external sources.
 - The first newsletter would go out in February 2020.

The next meeting is scheduled on Tuesday 7th January 2020.

- **8.4 Relocation of Defibrillator at Bradford Lane** The Headmaster of Nether Alderley Primary School confirmed the defibrillator was purchased from NHS Supply Chain and it was guaranteed until 2020. Councillors discussed the feasibility of relocating the existing defibrillator to the telephone kiosk on Bradford Lane and discussed whether it could be done when the new defibrillator is installed at Monks Heath. The Clerk was asked to make further enquiries.
- **8.5** Parish Cluster Group A meeting had taken place on Wednesday 6th November 2019 to discuss the following:
 - An update on the Police Meeting re: Alderley Edge Library
 - Producing a centralised Newsletter covering key issues
 - Parish Council applications for a grant to the Alderley Edge Institute Trust
 - As part of the Alderley Edge Neighbourhood Development Plan, the creation of a safe cycle path from Alderley Edge into Wilmslow High School and on to Wilmslow Leisure Centre and railway station. Linking this new initiative to surrounding Parish Councils.

- **8.6 Surface maintenance of Ladies Lane update** Councillors noted that the surface maintenance of Ladies Lane has temporarily been resolved.
- 8.7 Highways:
 - **8.7.1 Concerns of speeding motorists on Welsh Row** The Highways department have referred this issue to the Traffic team and will report back. Cllr. Howick suggested raising this issue at the next Parish Cluster Group meeting to achieve a common objective which can be addressed as a group.
 - **8.7.2 Concerns of rainwater drainage on Welsh Row** The Clerk reported CEC Highways department are 'attempting to carry out gully emptying at the earliest convenience' which the Parish Council will continue to monitor.

 - Brick bus shelter, Alderley Park entrance, east side Congleton Road Moss building up on the roof.
 - All benches are in need of a wood treatment which will be carried out in Spring 2020.
- **10.2** Parish Precept and Taxbase arrangements for 2020/21 Cheshire East Council is due to fix its Taxbase for the financial year 2020/21 by Resolution of the Council on the 12th December 2019. The Taxbase for Nether Alderley Parish Council is likely to be 592.49 compared to a current amount of 510.66

NAPC Comment: The Parish Council note that local residents remain concerned about the impact that this application could potentially have should it be granted an approval. it will set a huge precedent for development not only in the greenbelt but for the other lake which neighbours many houses along Bollington Lane.

Therefore, once again the Parish Council strongly urge this application is refused for Greenbelt and Environmental protection and all comments made in our previous response remain. (Original comment sent 24th June 2019)

Proposal: Place a storage unit on site to safely and securely hold tools used to maintain the

land.

Location: Land on the side of Welsh Row, Nether Alderley, Macclesfield

National Grid Ref: 383817 376858

NAPC Comment: The Parish Council noted this application has been made retrospectively as the storage unit has been in-situ for some considerable time.

The storage unit is presently situated on the curtilage of Welsh row and is an eyesore for neighbouring properties and disproportionate to the area of land it is sited on.

Councillors noted the storage unit is 'to safely and securely hold tools used to maintain the land'. However, it is evident there has been no maintenance of the site for several years, with the exception of chopping down a mature historic oak tree, without permission, to accommodate the storage unit.

The Parish Council strongly recommend this application be refused as it is inappropriate use of the greenbelt and suggest the storage unit is removed.

Decision: APPROVED 19.09.19

The Parish Council were disappointed that this application had been approved and noted that whilst there is an appeal process for the applicant there is no appeal process from neighbours who had submitted objections. The Clerk had been instructed to write to the planning officer expressing the following concerns:

- The application had been determined by delegated authority despite have had 10+ objections which should have automatically triggered it being called into committee.
- A total disregard for regulations regarding development in the green belt.
- Astounded that Highways had no objections to the creation of a <u>new</u> entrance which exits dangerously onto the junction with Sand Lane.
- Condition 4 states that 'the development hereby permitted shall be of personal recreation use only', However, the applicant is a commercial enterprise and cannot therefore adhere to this condition.

The Senior Planning Officer from CEC confirmed:

- They do not have a policy where applications with 10+ objections automatically get called into committee. The neighbour comments were taken into consideration but it was considered that the application complied with the Local Plan policy. However, if the applicant is using the stables commercially, they would probably need to vary the condition. The main aim of the condition is to prevent a commercial livery so it is limited to a single owner.
- The existing access has been in position for over 10 years so has now become lawful.

A local resident attended the Parish Council meeting and informed Councillors that Stirling Properties allegedly purchased the land speculatively and have two other sites in the immediate vicinity. Cllr. Jenny Shufflebottom, Chairman of the Planning Committee, confirmed that should a planning application for housing be submitted in the future, the Parish Council would ask that the application be called into committee rather than delegated authority.
