The Strategic Planning meeting will take place at 10.30am on Wednesday 24th February at Macclesfield Town Hall and the NAPC has registered has an attendee with the opportunity to deliver a 5 minute presentation outlining the observations and recommendations of the Parish Council.

The Parish Council has resolved that the planning meeting will be attended by Cllr Shufflebottom (if circumstances allow) and Cllr Bentley. An agreed statement will be read to the Planning Committee by one of the Councillors.

The contents of the agreed statement were discussed taking into consideration the TRICS principles, alongside the previous detailed responses put forward by both the NAPC and the residents of NA.(including NARPA) Discussion about the importance of maintaining the current amicable relationship with both MSP and Bruntwood took place and it was agreed that it should be included within the statement

The Parish Council agreed the parameters for the Strategic Planning Board Presentation Statement. Proposed by CM and seconded by JW

Discussion was held about the official wording that should be put forward with regards to the s106 alongside the possible necessity to seek other revenue streams such as "Match Funding".

The Parish Council resolved to put forward the following as a proposed heading for the s106,

"£145,000 towards general refurbishment to the structural integrity of Nether Alderley Parish Hall to provide improved facilities for future generations in a growing community."

6. Nether Alderley Roundabout

To consider recent correspondence with Cheshire East Council about improvements to the roundabout and further actions to take.

Chair confirmed correspondence with Adrian Shields and David Brown about the protracted issue of the roundabout. AS has confirmed that the issue will be take n forward and has requested a secondary design for the roundabout as the initial plan included boulders, which would compromise health and safety regulations. JW also highlighted land adjacent to the roundabout that may be included in future meetings and projects.

The Parish Council resolved to arrange a future meeting to discuss any future design and name of roundabout The Parish Council resolved to ask Mrs Langham on her return to arrange meeting
