To consider and agree actions relating to ongoing matters as follows:

8.1 Parish Hall renovation update – The Parish Council endorsed that the core renovations should be addressed with some additional storage and unanimously agreed not to deviate from the original plan. In order to move the project forward, a structured cost plan and schedule of work is required. Cllr. Shufflebottom will contact Mr. Andrew Ramshore (Listed Planning Officer at CEC) to arrange an informal meeting with him to establish what the possibilities are of rebuilding the external storeroom with access from the parish hall which would provide additional storage for tables/chairs etc. and report back. The original s106 money (£145,000) is indexed linked. However, Councillors envisaged there could be a funding gap which will need to be addressed subject to confirmation of costs. Councillors discussed the

- opportunity to increase the precept next year, taking into consideration the additional housing at Alderley Park which may provide the shortfall.
- **8.2 Neighbourhood Plan update** Cllr. Howick, Vice Chairman, will lead a strong and enthusiastic working group to produce a Neighbourhood Plan. A very productive meeting had taken place earlier in the day which included a consultant, Mr. David Proudlove of D2H, who had been asked to produce a proposal of how he could assist in producing a Neighbourhood Plan and associated costs. It was agreed that much of the Neighbourhood Plan could be based on the Parish Plan which was produced in 2014. The working group are keen to move the project forward and will report back at the next meeting.

RESOLVED: The Parish Council resolved to formally write to Cheshire East Council (Mr. Tom Evans) to inform them of Nether Alderley Parish Council's intention to formulate an action plan to produce a Neighbourhood Plan.

- **8.3 Highways and Potholes** The Parish Council had received a letter from the Highways Department (CEC) in response to Esther McVey's letter (MP for Tatton) requesting that repairs to Congleton Road should be moved higher up on the priority list. Cllr. Walton (Chelford Ward) stated that the highways budget was inadequate to meet demand as this is a national problem. The Parish Council asked the Clerk to write to Esther McVey once again restating the problem and asking her to lobby Central Government for more money in order to achieve better quality repairs.
- **8.4 New Councillor vacancies update** The Clerk reported that two local candidates have submitted an expression of interest form. Cllr. Shufflebottom will arrange an informal meeting with both applicants and will be assisted by Cllr. Howick, Vice-Chairman and another councillor.
