- **8.1.4** New CEC initiative: Local Highways Funding Cllr. Asquith confirmed there is a form available to apply for highways' funding and will forward a copy to the Clerk.

- **8.2** Parish Hall renovation update Cllr. Howick is waiting to hear from the Quantity Surveyor in order to progress the renovation.
- 8.3 Neighbourhood Plan update:
  - 8.3.1 Cllr. Howick confirmed the application for part 2 of the funding has been submitted.
  - **8.3.2** David Proudlove of URBME, the Neighbourhood Plan consultant, is waiting for a date to be confirmed for a meeting with Tom Evans at Cheshire East Council, for a full status update of Nether Alderley Parish Council's Neighbourhood Plan.
- 8.4 Highways Issues:
  - **8.4.1 Highways Working Group update** The Clerk was asked to arrange a meeting with a representative from Cheshire East Highways to discuss the issues in Nether Alderley.
  - **8.4.2** Surface dressing works on A34/Congleton Road Cheshire East Highways programmed the surface dressing works between 9.00 16.00 on the following dates:

Although works have allegedly been completed, Councillors noted there remains some pot holes on A34 and intend to raise this at the proposed meeting with Cheshire East Highways (date TBC).

- **8.4.3** Police Commissioner to call a public meeting to discuss A34 issues A public meeting had been scheduled for Thursday 2<sup>nd</sup> September 2021 (6.30 8.00 p.m.) at the Festival Hall. However, due to local elections, the meeting had been cancelled and will be rescheduled.

Craig Brown (Deputy Leader of CEC) confirmed the additional 2 bus stops to Wythenshawe Hospital and Manchester Airport had been added at the request of Handforth Parish Council. As the explanation was acceptable to the Parish Council, Cllr. Howick recommended the proposed contribution (£2,000) should be made available to Cheshire East Council.

**NAPC Comment:** Whilst the Parish Council appreciates there is a presumption in favour of development of derelict barns, this particular application is very sensitive and the Parish Council would like to make the following comments:

- 1. The application states that it would be barn conversions when in fact the barns are derelict so basically they will be new developments using only the footprints.
- 2. The 2 dwellings lie within the curtilage of a historic listed farmhouse and any development in such close proximity needs to be sensitive and give due respect to the listing. Within the curtilage there has already been a barn converted into a dwelling which has to consider the listing element when applying for any changes. Therefore, the Parish Council would ask that the same consideration be compulsory with this new application. To that end, should a permission be granted we would ask that all permitted development rights be removed so that any future development requires due consideration to protect neighbouring properties.
- 3. The proposed dwellings are in very close proximity to existing properties and the Parish Council request that special attention be paid to boundary treatments to ensure privacy, so as not to remove any residential amenity that these properties currently enjoy.
- 4. In addition, the Parish Council ask that special consideration be given to external lighting to minimise light pollution which could adversely affect existing dwellings.

**NAPC Comment:** Nether Alderley Parish Council strongly objects to this application which cannot be supported for the following reasons:

1. At present it is a green field in the Greenbelt on a lane steeped in history.

- 2. It cannot be classed as ribbon development
- 3. There is no planning policy that can support development on this land.
- 4. There is no brownfield element and there are no special circumstances.

In addition, the plot has recently had a significant old oak tree removed without permission which angered and saddened both local residents and the Parish Council.

Nether Alderley Parish Council ask that this application be REFUSED.

Under these proposals, through permitted development rights, masts up to a maximum height of 30 metres in unprotected areas and 25 metres in protected area will be permitted.

The proposed planning changes in the technical consultation aim to strike an appropriate balance between providing local control and delivering improved connectivity. The Government will consider the responses to the consultation before deciding how to take the proposals forward. Implementing any changes will require amendments to existing planning legislation.

The Parish Council supports the residents views and concerns and will monitor the outcome of the proposals following the consultation which closed on 14<sup>th</sup> June 2021.
