8. Current Matters

To consider and agree actions relating to ongoing matters as follows:

8.1 Parish Hall renovation update:

**8.1.1 Parish Hall Lighting** – Councillors considered and discussed replacing the sodium light bulbs with low energy bulbs which would be more cost effective.

RESOLVED: The Parish Council resolved to approve to replace the current sodium light bulbs with low energy bulbs including the cost to fit them which will require scaffolding.

**8.2 Parish freesheet newsletter** – Cllrs. Shufflebottom and Farrell will arrange to meet Revd. Jon Hale to formalise the practicalities of producing/distributing the newsletter.

Cllr. Marc Asquith left the meeting to attend a Parish Council meeting at Marthall (7.16 p.m.)

- **8.3 Community Speed Watch update** The Clerk reported a local parish was interested in purchasing the speed gun, subject to approval at their next Parish Council meeting.
- 8.4 Highways:
  - **8.4.1 Nursery Lane** The Clerk reported the problem to Cheshire East Highways on 2<sup>nd</sup> July 2019 via their website (Ref.: 3363998). Councillors noted the response emailed on 21<sup>st</sup> August and will continue to monitor the situation:

'All roads and footways on the highway network are regularly inspected as part of our scheduled safety inspection regime.

The Ditches at Nursery Lane, Nether Alderley has been assessed and will be considered for inclusion in an appropriate future programme. At this stage, I am unable to give you any indication on timescale.

In the meantime, we will continue to monitor the condition of this location via the scheduled inspection regime, and keep it in a safe condition for all highway users.'

- **8.4.2 Congleton Road/bus stop facing north entrance to Alderley Park** A notice has been issued by Cheshire East Highways to the land owner regarding the overgrown hedges.
- **8.4.3 A34 Bypass** Cheshire East Highways confirmed they are awaiting quotations to reinstate the fence panels which have blown down along the A34 Bypass and will keep the Parish Council updated.
- **8.4.4 Boundary Sign** There has been no update from the Clerk at Great Warford Parish Council regarding repairs to the boundary sign which Cheshire East Highways have agreed to undertake. The Clerk will pursue this matter and report back to Council.

#### 9. New Matters

To consider and agree actions relating to new matters as follows:

**9.1 Future working arrangements with Alderley Park** – Councillors noted the Alderley Park Liaison Committee meetings were moving away from issues which it had originally been formed and should be brought to the attention of the Chairman of the Alderley Park Liaison Committee and copied to Adrian Crowther (CEC Planning Inspector for Alderley Park).

Cllrs. Howick, Shufflebottom, Bentley and Farrell recently met with Nick Hynes of Alderley Park Ltd. to discuss and consider forming a working party to increase better working relations and communications with issues directly relating to Nether Alderley. It was agreed the meetings would be informal and on an adhoc basis as required and Cllrs. Howick, Clarke, Bentley and Joseph would represent the Parish Council. Other items which were discussed were:

- Alderley Park participation in a future public exhibition of the proposed plans for the refurbishment of the Parish Hall.
- Guidance in the procurement of services i.e. Quantity surveyor
- Support in the development of a new Parish Council website
- Allocation of s106 money against the proposed 25 additional dwellings currently going through the planning application process.
- Precept (which will be on the agenda of the next Alderley Park Liaison meeting)
- The state of the general landscaping surrounding Alderley Park which is the responsibility of Cheshire East Highways
- Rogue advertising signs
- Nether Alderley Parish Council being included in the 'Alderley Park Collective' which is invaluable
- **9.2 St. Mary's contribution towards JMC finances** The Parish Council discussed and considered the request to defer the second instalment of St. Mary's contribution of 50% of the 2019 forecast deficit of the Parish Hall.

RESOLVED: The Parish Council resolved to approve to defer the second instalment of St. Mary's contribution until the JMC accounts for 2019 have been finalised.

- 9.4 Manchester Airport Future Airspace In 2017 the Government published a policy on the future of UK airspace. This made it clear that modernisation is essential and also led to the industry's regulator, the Civil Aviation Authority (CAA), developing the Airspace Modernisation Strategy (CAP1711). The strategy reflects the fact UK airspace is among the busiest in the world, having been designed for a different era. One of the foundations of this strategy is the need to respond to changes in technology and the improved navigational capabilities of current aircraft. NAPC Comment: Further to my email of 31<sup>st</sup> July 2019 to Adrian Crowther requesting an extension of time to clarify some of the issues raised, Nether Alderley Parish Council have given this application much thought having taken into consideration comments from the few residents living on Alderley Park.

There is whole hearted support from <u>all</u> Nether Alderley residents, including the residents of Alderley Park, for a pub to be opened once again in Nether Alderley and for it to be a "straight forward" gastropub rather than a high-end restaurant.

The Parish Council acknowledge that car-parking issues have been re-addressed to accommodate more spaces generally. However, there remains on-going concern that individual applications on the residential area of the park, have offered the minimal number of spaces which the Parish Council consider will cause future issues.

Access to the resident's visitor's car park at the East Courtyard remains a concern as this will be shared with the gastropub which could potentially be used by their customers. It is stated in the application that there will be a 'parking management system' but no further detail is given. The Parish Council do not consider a reporting mechanism is a viable protection for residents as it will be retrospective and is unlikely to be operational 24/7 or late into the evening i.e. if a car misuses a resident's car park and is then reported, the inconvenience will already have occurred. Councillors noted the application's documentation originally stated 'signage and security' without reference to the type of security.

The Parish Council strongly recommend proactive preventative measures are required and would suggest an electric gate/barrier should be installed and maintained as part of the gastropub development. Whilst the residents living on the park bought their houses in the knowledge that a pub was proposed, we need to do everything we can to protect their residential amenity.

In conclusion, the Parish Council understand that visitor parking is minimal and therefore any designated car parking is precious and should not be taken up by gastropub customers.
