# Minutes of the Parish Council Meeting held on Tuesday 15<sup>th</sup> September 2015 at 7.00 pm at Nether Alderley Parish Hall.

#### 1. To receive apologies for absence

The Parish Council received apologies for absence from Nether Alderley Parish Councillors Mr. Dave Colgan, Mr. Simon Lewis and Mrs. Caroline McKeown

2. To receive Declarations of Interests and confirm Code of Conduct expectations and procedures

The Clerk re-affirmed expectations relating to Councillor action should pecuniary interests be declared and proposed to seek further advice regarding non-pecuniary interests

#### 2.1 To Declare Disclosable pecuniary interests.

No declarations were made.

2.2 To Declare interests conflicting with the seven Nolan principles.

No declarations were made.

#### 3. To consider and approve Applications for Dispensations

No applications for dispensation were submitted

#### 4. Meeting Minutes

DECISION: The Parish Council resolved to approve that the Minutes of the Nether Alderley Parish Council meeting held on Monday 10<sup>th</sup> August 2015 are a true and accurate record.

5. To consider the outcome of requests to Cheshire East Council regarding speed, speed limits and road safety on local lanes and information and advice received from Cheshire East Highways Officers

DECISION: The Parish Council resolved to approve that notes taken at a meeting with Cheshire East Highways and Cheshire Constabulary representatives on 10<sup>th</sup> September 2015 were a true and accurate record.

The Parish Council considered and discussed a meeting held with Cheshire East Highways Officers, representatives of Cheshire Constabulary and representatives of two Parish Plan Working Groups in relation to its letter sent to the Strategic Commissioning Manager for Highways in May 2015 asking for measures to be put in place to address speed, speed limits and safety on Congleton Road and other local lanes.

DECISION: In response to Parish Council requests for safety improvements and speed limit reductions, the proposals and responses from Cheshire East Highways Officers were considered and the Parish Council resolved to make the following responses:

- reluctant acceptance of maintenance of the 40 mph speed limit on Congleton Road, with support for additional speed enforcement mechanisms instated to effectively regulate traffic at this limit but continued support for a speed limit reduction to 30 mph.
- support of the adoption of the new Cheshire East Council advisory 20 mph speed limit on Congleton Road in the vicinity of the Primary School, at school entry and exit times and within this financial year
- support for the instating of road markings to denote a crossing area within the 20 mph zone on Congleton Road.
- support for the installation of a new speed camera on Congleton Road, near to the Primary School, operating in both traffic directions with a request for funding from Cheshire East Council

- Support for the proposal to reduce speed limit to 40 mph on Sand Lane and Welsh Row but still in favour of reduction to 30 mph
- continued serious concerns about speed and safety on Artists Lane with a request that speed limit is still considered for reduction and query whether 40 mph could be considered
- not to pursue signage for a ban on parking in the bus lay bye at this time. Addressing the visibility to the south of Congleton Road was discussed and decision to seek further advice approved
- that Cheshire East Highways will look at signage and highways hardware and will look to improving safety by optimizing and reviewing signage.

#### 7. Matters Arising

#### 7.1 To consider progress of Work to Oak Tree in Burial Ground

The Clerk confirmed and described work carried out to the oak tree in the Burial Ground, further to tree works permission granted by Cheshire East Council.

The Parish Council confirmed approval that the Chairman had replaced a planter damaged during the works.

#### 7.2 Cheshire East Local Plan.

DECISION: The Parish Council resolved to approve that Mrs. Shorland attends a meeting on 6<sup>th</sup> October that will provide an update on progress of the Plan and resumed hearings.

DECISION: The Parish Council discussed communication received regarding the Local Plan and resolved that is does not request to participate in the resumed hearing sessions that will address recent additional evidence and does not intend to submit a further statement. The Parish Council resolved that it does wish to participate in hearing sessions it has already applied to participate in.

#### 7.3 s106 Provision

DECISION: Taking in to account responses to the Parish Plan survey and matters of local need raised with the Parish Council and identified by the Parish Council over previous years, the Parish Council resolved to approve that the following matters are identified local considerations for s106 provision:

- Children's play area
- Restoration and upgrade of the Parish Hall
- Installation of a speed camera on Congleton Road, near to the Primary School
- Nether Alderley welcome boundary signs
- Traffic calming/strips in the vicinity of the Mill
- Restoration of the Saxon Cross
- Engagement of a lengthsman
- Extension of Burial Ground land

Mrs. Shufflebottom explained advice received from Cheshire East Council regarding each suggested area of local need/benefit and it was agreed that restoration of the cross and engagement of a lengthsman may not be considered to fit s106 parameters. The Parish Council agreed that it hoped that Cheshire East Council would fund a speed camera.

DECISION: The Parish Council resolved to approve that Mrs. Shufflebottom represents the Parish Council at a meeting to raise the other s106 proposals identified.

#### 7.4 Nether Alderley Roundabout

The Parish Council is awaiting arrangement of a meeting with Cheshire East Council to discuss landscaping of the roundabout.

DECISION: The Parish Council approved that a sculpture on the roundabout may be a valuable feature and that Alderley Park may be approached to consider involvement with this.

#### 7.5 Parish Hall Renovation.

DECISION: The Parish Council resolved to consider at the next Parish Council meeting.

#### 7.6 Telephone Kiosk

DECISION: The Parish Council resolved to approve that a Working Group of Councillors meets to consider a draft Highways licence received by Cheshire East Council and the next stage of the kiosk 'adoption' process, to feed back to the Parish Council at its next meeting.

DECISION: The Parish Council resolved to approve expenditure of £125 for purchase of the required Kiosk Highways licence.

DECISION: Further to advice from Cheshire Association of Local Councils and consideration of Parish Council powers for expenditure, the Parish Council resolved to approve that the Parish Council allocates funding for purchase of the telephone kiosk and highways licence by way of Local Government Act 1972 Section 137 in that the expenditure is for a benefit to the community where there is no other specific power covering the action and that the expenditure is commensurate with the benefit to the community.

Proposed by Mrs. Shorland, Seconded by Mrs. Bentley and approved by resolution of the Parish Council

#### 7.7 Highways Licence - Jubilee Bench

The Clerk explained recent communication with Mr. Simon Davies, Cheshire East Highways, who is still pursuing an updated licence for the bench.

#### 7.8 Painting Work.

The Clerk explained recent communication with Public Rights of Way Department regarding the painting of the kissing gate. The Parish Council agreed that further consideration is given to painting the gate at the Burial Board meeting.

DECISION: The Parish Council resolved to approve that this correspondence is considered at the next Parish Council meeting.

#### 8.2 Cheshire Constabulary.

The Clerk explained a policing update received from the Parish PCSO and update regarding the Saddlebridge Unit from the Knutsford Beat Officer.

DECISION: The Parish Council resolved to approve that other policing correspondence is moved to the next Parish Council meeting.

DECISION: The Parish Council resolved that it did not have a response to send to this Cheshire East Council consultation.

LAND ADJACENT TO HIGHLANDS, CONGLETON ROAD, ALDERLEY EDGE, CHESHIRE, SK9 7AD

DECISION: The Parish Council resolved to consider a full response to this planning application at its next meeting but in view of dates allocated for response by Cheshire East Planning and the nature of the application, the Parish Council resolved to request that the application is called to Committee for the following reasons:

- 1. The proposed development would set a precedent for new development within the Green Belt (on Green Belt land) and within the Conservation area.
- 2. The proposed development would be on Green Belt land; not on brown field within Green Belt
- 3. The size of the proposed property is very extensive
- 4. The style of the proposed property is not in keeping with surrounding properties.
