# Minutes of the Meeting held at 7.00pm on Tuesday 12<sup>th</sup> November 2013 at Nether Alderley Parish Hall.

# 1. Apologies

Apologies were received from Mr. Lewis, Mrs. Reynolds and Mrs. Worthington

# 2. Approval of Minutes.

The Minutes of the Parish Council meeting held on Monday 14<sup>th</sup> October 2013 were confirmed as a true and accurate record and approved *by resolution of the Parish Council.* 

The Clerk drew attention to Minute reference 11/9/13:9 where the Clerk's salary payment was recorded as £564.790. The Clerk confirmed that this was a typing error and that the amount should have been recorded as £564.70. **The Parish Council approved that the Clerk pencil a reference to today's minutes next to the error.**

#### 5. Matters Arising.

# 6.1 Parish Plan

Mrs. Worthington gave a report about the last meeting of the Parish Plan Steering Group. A public meeting, to present the findings of the Parish Plan survey, has been arranged for 27<sup>th</sup> November and invitations will be delivered by hand to all Nether Alderley residences in the next few days. The evening event will include presentations from Astra Zeneca regarding the future of the Alderley Park site and Cheshire East Council regarding Superfast Broadband.

#### **6.2 Christmas Tree in Nether Alderley**

Mr. Clarke explained a recent conversation he had had with a Cheshire East Officer. He has been referred to speak with Simon Davies, Cheshire East Highways.

The Clerk drew attention to recent communication received from the insurance company regarding Christmas trees.

# 6.3 Excavation of Grass verges alongside Highways in Nether Alderley.

Further to liaison between the Parish Council and Cheshire East Council, Cheshire East has excavated the verges along the A537 and the B5359 with funding from the Route Management programme. Councillors expressed their delight at the outcome of the work.

Andrea Bickerton at Cheshire East Highways has confirmed that the Council will be unable to carry out a further cut of the grass on the Nether Alderley roundabout but

would be in agreement for the Parish Council to contact, the Borough Council's verge contractor, and arrange for and fund the work. The Clerk has requested a quotation from the contractor for the work.

Ms. Bickerton had explained possible plans for future planting at the roundabout, to the Clerk. The Clerk explained the plans to the Parish Council. The Parish Council agreed that the Clerk should ask that residents local to Heawood are also consulted on the suggested plans.

# **6.4 Parish Councillor Vacancy**

Notices have now been placed on the Parish Council notice boards and on the website, advertising the Parish Councillor vacancy.

# **6.5 Community Pride Awards**

Further to the Community Awards ceremony, a briefing has been received from Cheshire Community Action which the Clerk reported back to the Parish Council.

# 6.6 Speed Congleton Road

Inspector Mitchell has been invited to attend a Parish Council meeting to discuss speed control along Congleton Road and other lanes in the parish.

PCSO Whitehead has reported that she carried out speed enforcement last week on Congleton Road near to the primary school but did not identify anyone speeding. A SID device was positioned on Congleton Road between 17<sup>th</sup> and 20<sup>th</sup> October.

# **6.7 Planning Permission Change of Use.**

As requested by the Parish Council, the Clerk had contacted a Planning Officer for advice and information regarding the current situation with change of use permissions. The Clerk detailed the information to the Parish Council and also outlined information received regarding new policy for change of use to office accommodation.

# 6.8 Connecting Cheshire Superfast Broadband.

An update was e-mailed to all Parish Councillors prior to the meeting.

# 6.9 Bypass Compensation.

Communication has been received from a local resident expressing concerns over the length of time compensation claims are taking for residents. The Parish Council approved that it would write to George Osborne.

# 7 Correspondence.

# **7.1 Local Councils Information Book**

The Parish Council approved the Clerk purchasing a copy of a new NALC publication 'Local Councils Explained' at the cost of £49.99 plus £5 postage.

# 7.2 Cheshire East Council Core Strategy Consultation.

Further to forwarding information and a link to the Strategy documentation to all Parish Councillors prior to the meeting, the Clerk gave details of the current consultation and its relation to the future Cheshire East Local Plan. The Parish Council agreed that Councillors should study the document prior to the Parish Council meeting in December, to identify areas and proposals that will impact upon Nether Alderley. The Parish Council agreed that a response to the consultation should be formulated after discussion at the December meeting.

# 7.3 Knutsford Local Area Partnership Minor works programme

The Parish Council considered requests that it has previously submitted to the Knutsford LAP for action, that are currently on the programme list. The Parish Council discussed other Highways issues that could be referred to the LAP.

The Parish Council approved that the Nether Alderley issues on the current list should be maintained. The requests include reduction in speed limit along Artists Lane, Bollington Lane, Sand Lane, Soss Moss Lane, Nursery Lane and Welsh Row; reduction in speed limit on the A34 Bypass and at Nether Alderley roundabout; reduction in speed limit along Congleton Road and speed devices in the vicinity of the Primary School. The Parish Council approved that attention should be drawn to the new request, recently submitted after the October meeting, for creation of a 20 mph school speed safety zone along Congleton Road in the vicinity of the Primary School at key school times. The Parish Council approved that particular attention should be drawn to the serious concern about traffic speed along the newly widened stretch of Bollington Lane, overtaking along this lane, concerns over safety of those exiting the residential/business section of Bollington Lane on to the widened stretch and concerns for the safety of pedestrians trying to negotiate this fast stretch of road that has no pavement.

The Parish Council approved that the Clerk should forward the comments to Cllr. George Walton for submission to and consideration by the Knutsford Local Area Partnership.

# 7.4 Meeting with Local Parish Council Chairmen.

Mr. Clarke explained that, further to communication from the Chairman of Great Warford Parish Council, a meeting has been planned for Chairmen of a number of local Parish Councils to discuss common issues. Mr. Clarke plans to attend the meeting
